- 3.) Orders for any Holiday Catalog must be placed 30 days in advance of the Holiday to guarantee availability. Orders for the Everyday Catalog must be placed at least 2 weeks in advance to guarantee availability.
- 4.) Buyer will earn 40% profit on Fundraising Catalog Items. (50% on Fundraising Candy Bars.)
- 5.) Invoices over \$1,500 may be delivered free of charge within 50 miles of the factory of the Seller; invoices under \$1,500 are picked up at any of the Seller's various retail locations, or may be delivered for an additional charge.

- 6.) Buyer agrees to pay Seller the full amount of invoice at the time of delivery or pick up.
- 7.) Fowler's will accept cash, organization checks, certified checks, and/or credit cards. There is a service charge of \$35 for returned checks.
- 8.) All sales are final. Returns will not be accepted for any orders from the Catalog Fundraiser.
- 9.) All sales are subject to sales tax unless a Tax Exempt Organization Certificate is filled out and on file with the Seller. (Copies of this form are available by request). There is no sales tax on Gift Cards.
- 10.) In the event the Buyer cancels an order, the Buyer may be responsible for the value of the order.
- 11.) In the event of collection services being implemented for the collection of outstanding obligations, the expense of attorney's fees and collection costs will be borne by the Buyer.
- 12.) The individual who signs this agreement on behalf of the Buyer does acknowledge that he or she has the authority to execute this agreement on behalf of the Buyer, and is personally responsible for payment to Seller.
